Environmental Justice: A Mission for Wisconsin

- History of systemic racism, exclusionary practices, and segregation (both direct and indirect) have led to worse economic and health outcomes for communities of color, rural communities, and lowincome communities.
- In Wisconsin, these practices have led to very specific disproportionate outcomes in many socioeconomic areas.
- This disproportionality extends to exposure to environmental harms and risks.






Environmental Justice is About Holistic Equity
