

# IMPLEMENTATION STATUS OF PROJECTS IN THE 2025 THROUGH 2028 TRANSPORTATION IMPROVEMENT PROGRAM FOR SOUTHEASTERN WISCONSIN

Tables B.1 through B.7 list by county the 280 projects that were included in the 2023-2026 Transportation Improvement Program (TIP) that were completed (230), dropped from consideration in the TIP (23), and have no work scheduled until beyond the last year of the 2025-2028 TIP (27). In each table, projects that have been completed are listed first; followed by the projects which have been dropped, or are no longer being considered for implementation; followed by projects that have no work scheduled until beyond the last year of the TIP. Within each category of project implementation, projects are in order by project type category: bicycle and pedestrian expansion, bicycle and pedestrian improvement, bicycle and pedestrian preservation, highway related environmental enhancement, highway expansion, highway improvement, highway preservation, highway safety, transit expansion, transit improvement, transit preservation, and off-system highway improvement. An explanation of the abbreviations used in the appendix follows:
